Form 990, Part III, Line 3 - During 2020, International Sanctuary was dramatically impacted by COVID-19. The sales of jewelry handcrafted by our beneficiaries declined by more than 50% due to lockdowns, supply-chain issues, and the inability to sell the jewelry through historical events and wholesale channels. Our program delivery shifted online and focused on health, education, and community. Outreach activities were severely restricted given quarantine regulations, travel closures, and limited vaccination availability in the developing countries in which we operate. In spite of these challenges, funding of all international operations continued in full. International participants continued to attain development goals and a new sanctuary was opened in Cebu, Philippines. Unfortunately, the US program was suspended; operations were not deemed essential by the government. We helped our US participants access the enhanced COVID-19 US unemployment insurance, and our significantly reduced US operations were funded with two rounds of the US Payroll Protection Program, which will be fully forgiven during the next fiscal year.
